

## **End-User License Agreement**

### **IMPORTANT – Please Read Carefully:**

This End User License Agreement (“EULA”) is a legal agreement between you, the Licensee, and Extendo ApS (“Extendo”) for CVR Integrator (“Software”) to be used in Microsoft Dynamics 365 Business Central. By installing, copying, or using the Software, you agree to be bound by the terms of this EULA.

The Software and its documentation are copyrighted by Extendo. Under this EULA, you are granted a non-exclusive right to use the Software for the duration of this agreement. This EULA does not transfer ownership of any copyright or other intellectual property rights in the Software to you.

Using the Software indicates your acceptance of this EULA.

### **Definitions**

In this EULA, unless otherwise stated:

- “EULA” refers to this End User License Agreement.
- “Licensee” refers to you or the organization you represent.
- “Documentation” includes written materials, knowledge base articles, emails, training guides, and help content provided by Extendo to assist in using the Software.
- “Software” refers to the software provided by Extendo for your use.
- “Invoice” refers to the sales invoice provided by your software provider or Extendo for the Software covered by this EULA.

### **Grant of License**

Under this EULA, you may install the Software on a single production server and on any number of failover servers, provided only one server is actively used as the production environment. You may install the Software on multiple test or development servers. All installations are subject to any restrictions noted on the Invoice, including but not limited to limits on users, devices, or companies.

You may not copy or use the Software or Documentation except as expressly permitted by this License. Unauthorized actions such as copying (except for reasonable internal backup), distributing, transferring, sublicensing, renting, leasing, lending, selling, or allowing third-party use of the Software are prohibited. Modifying, reverse engineering, decompiling, disassembling, or otherwise reducing the Software to a human-perceivable form is not allowed, except as expressly permitted by law and after notifying Extendo in writing.

You acknowledge that all rights, titles, and interests in the Software and Documentation, including patents, trademarks, designs, copyrights, and other intellectual property rights, remain with Extendo and/or its licensors. You do not acquire any rights beyond the limited license described in this agreement.

## **Warranty**

Extendo and its licensors provide the Software and Documentation "as-is" without any warranties, express, implied, or statutory, including but not limited to warranties of merchantability, fitness for a particular purpose, satisfactory quality, accuracy, title, non-infringement, or freedom from defects. Extendo and its licensors disclaim all liability for such warranties.

Extendo, its licensors, and their respective subsidiaries will not be liable for any indirect, incidental, special, consequential, or punitive damages arising from this license, even if advised of the possibility of such damages. Some jurisdictions do not allow the exclusion of damages or limitation of liability, so these exclusions or limitations may not apply to you. Your rights may vary depending on your jurisdiction.

Extendo may provide updates or corrections to the Software at its discretion but is not obligated to offer support, maintenance, or updates.

## **Termination**

This License is effective until terminated. Extendo may terminate this License if you breach any provision. Upon termination, you must cease using the Software and Documentation and destroy all copies, confirming in writing to Extendo that you have done so.

## **License Breach**

You agree that any breach of the restrictions in this License would cause Extendo irreparable harm, for which monetary damages would be inadequate. In addition to damages and other remedies, Extendo may seek injunctive relief to prevent actual, threatened, or continued breaches of these License terms.

## **Trademarks**

All product and company names mentioned in this EULA, the Software, or the enclosed documentation may be trademarks of their respective owners. Their use in this EULA complies with relevant guidelines and licenses.

## **General Terms**

### **Court Location**

This License and any disputes arising from it are governed by the laws of Denmark. Disputes will be settled in accordance with Danish law, with The Court of Aarhus, Denmark, as the venue.

### **Severability and Waiver**

If any provision of this License is found to be illegal, invalid, or unenforceable, that provision will be enforced to the extent possible or deemed severed from this License. The remaining provisions will continue in full force and effect. Waiver of any breach or default does not constitute waiver of any other or subsequent breach.

### **Assignment**

You may not assign, sell, delegate, or transfer this License or any rights or obligations under it without Extendo's prior written consent.
